UMISC is on schedule: Formatting and graphic design for the conference program is being done by the Minnesota Department of Agriculture, thank you very much to them. A PDF of the word version is available or will be available on the conference website. A separate document houses poster abstracts and author biography information for speakers and will be available online for download. The hybrid conference will have a few prerecorded talks, and slides and audio will be live streamed through our online event conference platform again event mobi based on our conference experience as the ex-com and participant feedback, we have chosen use it again, the app will be accessible to attendees the first week in October. Promotion for the conference has been shared on social media newsletters and partner outreach. We currently have about 390 registrants. We've exceeded our in-person estimate but I underestimated the remote to 10 minutes on a field trip but attendance as well so our registration income is under by about \$50,000. In 2020 UMISC had 1000 registered, we expected 600 in 2020, possibly with registrations up-to the deadline.

- 290 are in person registered, 100 online registered
- 37 exhibitors including a booth reserved for MISAC
- Of the 37 exhibitors, 19 are sponsors, one Champion sponsor which is Wisconsin DNR, one event sponsor which is Michigan's invasive species program, 8 daily sponsors and 9 sessions sponsors
- Exceeded sponsorship and exhibitor goals by about \$19,400.
- Repayment to the 3 partner groups is likely to be under \$1,000.

Program overview:

Each of the four elements in the plan had their own strategies and workshopped metrics noted at our inperson meeting, are summarized in the notes from our July workshop sent out as a separate document.

Element 1 Prevention:

- state regulations were highlighted a lot
- federal and state inspections and enforcement

Element 2: Early detection and response

- develop response plans was kind of the big head for that group
- funding sources

Element 3: Management of Invasive Species

- integrated Pest Management plans
- coordination and communication
- evaluation as well for management and funding

Element 4: Leadership and coordination- less clear but a lot of focus on communication

#### Updates from Members

**Jim Calkins - Minnesota Nursery & Landscape Association-** Updated Jumping worms BMPs, shared with MDA for their distribution. Japanese apple rusts have been found in MN, the farthest west so far.

Jen Larson- USFS-St Paul Field Station We have several entomologist and plant pathogen folks, I am the Plant person. Some background, we don't have or manage a land base but support forest conservation with funding leadership and technical assistance. A big part of our work is partnerships with state and local governments tribes and educational institutions NGOs. We are primarily focused on non-federal lands. Jake Anderson - Nature Conservancy- Wrapping up field season, Marissa Ahlering our team scientist was recently published with their work on invasive cool season grass show no increased abundance with earlier growing seasons

**Kate Wyman Grothem – US FWS-** the upper Mississippi river basin's Horizon Scanning Project is still on going, if interested in attending the next meeting were in the midst of defining the scope, geography and taxa of the project, we would love to have the input, email shared in the chat

**Kelly Pennington-MN DNR-** Laura Van Riper has continued to shepherd the proposed rulemaking through our process, we hope to get it listed as a prohibited invasive species, and we'll inform the group when the rule making is open for comment, so no harm in keeping earthworm regulation on MISAC's future goals. DNR's Invasive Fish Coordinator organized a MUM, method targeting carp on the Mississippi, and found no invasive fish but it was a great response exercise with a number of agencies from the region. **Kelsey Taylor- Fond du Lac-** Wrapped up ricing surveys and season, no new species IS found, we are also doing a fall spearing and netting season which is new for us, as there some extra quota in terms of walleye harvest. We're also trying to form an indigenous conservation core crew with MN and IA to bridge the gap that's there.

**Liz Anderson- Lake SWCD-** nearing the finish line for a signage project at PWA's in the boundary waters, which Doug Jensen started and then Wildlife Forever helped with the final design and production and now its being handed off to us.

**Paul Erdman- BSWR-** BWSR Academy is coming up, unfortunately the same dates as UMISC, a couple restoration related sessions and we will distribute some calendars at the event. Brown Marmorated Stink Bugs would be a possible future talk for the group

**Rob Venette- MITPPC-** The Midwest stinkbug assistant, has an app that allows you to report and ID them. MITPPC has some continuing projects and have a dozen or so proposals being externally reviewed and a few projects starting this winter, keep an eye out for some press releases about that. Angie Gupta organized an invasive species community of practice group, which had great turn out at the arboretum looking at on the ground management. The North Central Forest Pest Workshop I attended was also a great regional event and showcased the work being done in Minnesota. **Sascha Lodge – Minnesota DNR Forestry**- We have a couple dozen invasive plant management projects going on or planned across the state and Forest Eidbo took a new job, as he attended these meetings some may be interested to know.

**Shawn Murphy- Metropolitan Mosquito Control District** – so far, no new invasive species found this season so far but our lab is still working on samples

Val Cervenka –Forest Health Program Coordinator MN DNR- After working on the North Central Forest Pest workshop all year long we had some awesome speakers, it went really well we had a hybrid meeting with some virtual speakers and attendees. While the focus isn't on invasive, we talk about them and if interested let me know I can put you on the mailing list. The event is in Wisconsin next year. A group of folks from Manitoba, Michigan, Wisconsin, and Minnesota, did a tour of spotted lantern fly and Asian longhorn beetle sites in Ohio, as part of the Forest Health Committee on the Great Lakes Forest Fire Compact, which allows MI WI MN and Manitoba travel quickly if need be, and part of our trainings include visiting sites where active management for species of concern. Angie Ambourn may be able to speak to this further at future meetings. It may be my last meeting, as I am retiring but it has been awesome to be part of this group.

**Chelsey Blanke- Anoka County Parks-** I finished up a seasonal role with Anoka County Parks doing some Terrestrial Restoration work, invasive species management, like oat wilt surveys, I'll be starting a new role shortly but will have more to share on that later on, hopefully continue to participate in MISAC. **Christina Bosch- MN DOT-** Working on update to Noxious Weed Book update for 2023, a PDF release

is expected in March of next year.

**Emily Dunlap- Three Rivers Park District**- Late summer wrapping up oriental bittersweet, transitioning into surveying. CPL Grant for Oriental Bittersweet control is wrapping up next June and were looking forward to comparing our treatment areas with contracted treatment sites. We're also continuing work on Jumping worms' surveys.

**Ariana Richardson - Meeker County-** Our 2023 grant cycle just opened up, we've focused on building up community resources and working with our grantees to focus on more long-term rather than seasonal control. We're hoping to set up volunteer training for PI Surveys and currently updating our monitoring sites and protocols for prevention and monitoring.

**Bob Dunning – County Ag Inspectors** – We may be looking for another letter of support from MISAC for 2023.

Jennifer Burington – MN Department of Agriculture- Our Palmer Amaranth Ad Campaign is on-going on social media, there is good click through reach. We are finishing up our surveys on apple rust and putting that out come January and an annual conference on spongey moth.

**Doug Jensen- MN DNR-** Updated earlier on UMISC, AIS Advisory Committee Meetings facilitated, working with partners in the northern part of the state to aid in end of year reporting. Great Lakes Panel meeting was set for Ann Arbor and has been moved to online Nov 1<sup>st</sup> -3<sup>rd</sup>. Red-Lake Reservation's project with MN DNR will see a Permeant AIS Station and Multiple CD3's installed, updates to follow. St Louis River Estuary may be delisted come 2028
